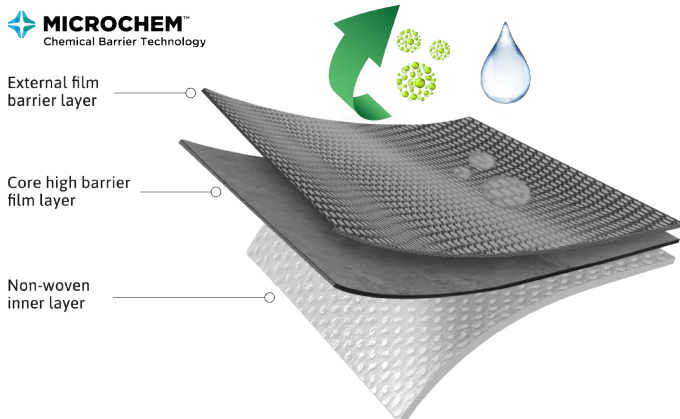

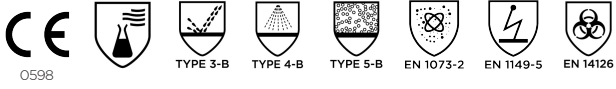
## Material Diagram
